



(1) 此物業是依據此拍賣章程內之一般拍賣條款出售,並依照特別拍賣條款如有適用 者而出售。如果特別拍賣條款與一般拍賣條款的內容出現矛盾之處,則以特別拍 賣條款內的指定為準。

The Property is sold according to the General Conditions of Sale as provided herein and further subject to the Special Conditions, if any, where applicable. In the event of conflict between any of the Special Conditions of Sale with the General Conditions of Sale, the Special Conditions of Sale shall prevail.

(2) 此物業是限有底價以價高者得,拍賣人有權將投價棄取如有爭執則以最後無爭執 之價為底價再行拍賣。凡投買者一經出價不得退縮,並比上次所出之價不得少過 拍賣人拍賣時所定之銀數。

Subject to a reserve price, the highest approved bidder being so allowed by the Auctioneer shall be the Purchaser thereof. The Auctioneer shall have the right to refuse any bid. If any dispute shall arise as to the highest bidder the Property shall be put up again at the last undisputed bid. 

Any notice required to be served on the Vendor shall be validly given if in writing and addressed to the Vendor or the Vendor's Solicitors and delivered to or sent by prepaid post to the Vendor or the Vendor's Solicitors at the address specified herein (as the case may be).
